SUBJECT: 2022 Humana Medicare Advantage PPO Plan Renewal

DATE: August 6, 2021

Since 2007 Clinton County has offered Humana Medicare Advantage PPO Plan to its retirees and spouses who are over the age of 65. Humana Medicare Advantage offers several advantages to our retirees including:

- All the benefits of original Medicare, plus extra benefits.
- The use of any physician, hospital, health service or pharmacy anywhere in the country that participates with Medicare.
- The plan covers both Medical and Pharmacy which means there is only one card for all care.
- Worldwide emergency coverage.
- Several programs to help improve health and well-being.

Humana initially presented a 3.88% increase for the 2022 renewal, however after some discussion, Humana lowered the renewal to a 2.9%.
