RESOLUTION 2020-15

APPROVING APPORTIONMENT, DRAIN AND SPECIAL ASSESSMENT REPORTS AND AUTHORIZING LOCAL UNITS TO SPREAD MILLAGES AND ASSESSMENTS CONTAINED IN THE REPORTS

WHEREAS, the 2020 total taxable value of real and personal property, subject to taxation in Clinton County is \$3,026,833,948.00; and

We, the Clinton County Board of Commissioners direct each unit to spread the allocated millage of 5.7691 mills for Clinton County, as well as the E-911 Millage rate of .8458; and

All rejected taxes; and


All special assessment districts, lighting and other; and
