## **RESOLUTION 2022 - 23** **AUTHORIZING SUBMISSION OF A MICHIGAN NATURAL RESOURCES** **SPARK GRANT APPLICATION**

WHEREAS, the Clinton County Parks and Green Space Commission has prepared a Michigan Natural Resources Spark Grant application titled "Motz County Park Universal Access Improvements" to pay for 100% of the costs to design and construct the proposed park amenities that will increase accessibility and available recreational opportunities within Motz County Park; and

WHEREAS, It is the responsibility of Clinton County to appropriate all funds necessary to the Parks and Green Space Department for continued maintenance of the property and grant project authorized by the Michigan Department of Natural Resources (MDNR); and

WHEREAS, the proposed application is supported by the *Clinton County Park, Recreation and Open Space Plan: 2020 — 2024*; and

WHEREAS, the Clinton County Parks and Green Space Commission has requested Clinton County Board of Commissioner's approval of the aforementioned grant application.

WHEREAS, Clinton County is to maintain satisfactory financial accounts, documents, records and will make them available to the MDNR for auditing purposes in a reasonable amount of time; and

WHEREAS, Clinton County will design and construct the project with the awarded Spark Grant funds and provide such services and materials as may be necessary to satisfy the terms of said Spark Grant Award; and

WHEREAS, Clinton County will regulate the use of the proposed improvements designed and constructed with the awarded Spark Grant funds to assure the use thereof by the public on equal and reasonable terms.

THEREFORE, BE IT RESOLVED, the Clinton County Board of Commissioners does hereby comply with any and all terms of said Spark Grant Award including all terms not specifically set forth in the foregoing portions of this Resolution.
