Dear Board of Commissioners:

In accordance with the provisions of Chapter 2, Section 31, of the Michigan Drain Code, which is Act 40 of the Public Acts of 1956, as amended, I respectfully submit my Annual Report for the Clinton County Drain Commissioner's office for the year ending December 31, 2018.

This report summarizes the activities of this office for 2018 and provides financial information for each of the active drain accounts for our county drains. It also includes comparative historical data that may be of interest to readers of this report.

Again in 2018, petitioned drain improvements kept us busy in addition to our regular duties. No new petitions were received in 2018 however, we continued working on nine projects that were petitioned in prior years. We prepared petitions for landowners on two other drains. One was returned in January of this year, but the other has yet to be returned.

Petitioned projects tend to consume a tremendous amount of time that is not normally associated with general maintenance projects. Tasks related to petitions include organizing board of determination meetings, survey, design and engineering, easement preparation and negotiations towards acquisition, additional financial considerations, and more.

Last year we were able to complete construction on two petitioned projects. The first was the Waltz & Sturgis Drain in Fowler and Dallas Township. We had applied for and received a Hazard Mitigation Grant from FEMA, and we are working to get the grant closed out so the remaining funds can be released to the drainage district. This has not been a popular project with many of the district property owners, but it will protect the residents of Fowler from flooding that had been so prevalent in recent years. The second was the Carter & Burke and Branches Drain in Watertown Township. This project will protect several homes that had been known to flood in years past.

While petitioned drain projects require a lot of time, we still focus on maintenance of our existing drains. With well over 800 miles of open and enclosed county drains, there is always plenty of maintenance work to be done. Don Theis of Northwest Excavating has been the "go to guy" for Clinton County drain maintenance work for most of the last 40 years. He had always been known for his quality work and attention to detail at a fair price. He could always be counted on if we needed a contractor on short notice. Sadly we lost Don in a tragic car accident in May and he is certainly missed. We have been working with

a few new contractors to pick up the slack, but our maintenance numbers were lower than in previous years while we transitioned the work to other contractors.

By statute, we are able to expend up to \$5,000 per mile per year on a given drain for maintenance work. This can be exceeded in an emergency or by a resolution from the affected township. Last year I requested and received one township resolution that allowed me to exceed the statutory spending limit to complete needed cleanout work on the Lehman Drain in Westphalia Township.

Each one of our over 630 county drains has its own drainage district. The drainage district is a legal entity and generally encompasses the parcels of land that contributes storm water runoff to the drain. Each district has its own financial records and is responsible for its own expenses.

One of the more recent duties of this office is that of Remonumentation Grant Administrator. After assuming these duties in 2016, Lynn Cech and I are handling the administrative duties with administering the annual grant. Last year the contract surveyors completed the Remonumentation of 48 government survey corners that were first established in the mid 1800s by the Government Land Office. We now have 1,241 corners completed with another 778 remaining.

Each September we hold a Day of Review of Apportionments for the drainage districts we are assessing for maintenance. Last August we mailed out over 4,500 Day of Review notices to landowners for the 52 drains we assessed for maintenance. This is important as we prefer to have landowners informed and aware of the assessments that appear on their winter tax bills. Of course we always welcome questions at any time from landowners about our work, however, the Day of Review provides another opportunity to talk about their concerns.

2018 Summary

The following bullet points offer a brief summary of 2018 Drain Commissioner's office activity:

- Performed general maintenance work or inspections on 215 drains.
- Cleaned out 15.84 miles of open drains.
- Performed major right of way clearing work on 1.63 miles of drains.
- Replaced 0.74 miles of enclosed tile drain.
- Assessed a total of \$853,185 to 88 drainage districts.
- Completed construction on two petitioned projects for the #897 Waltz & Sturgis Drain and the #950 Carter & Burke and Branches Drain.
- Established one new drainage district by the signing of an Order for Laying Out and Designating a Drainage District for the #090 Herbison & Wright Drain.
- Progressed with engineering and design work on seven previously petitioned drain projects. Received one petition for the #089 Looking Glass Brook Drain which is a new drain.
- Provided petitions for landowner circulation on the #913 Westphalia and Riley Drain and the #090 Herbison & Wright Drain.

- Revised the drainage district boundaries for two intercounty drains, the Maple River and the Looking Glass River, in accordance with Section 197 of the Drain Code.
- Reviewed or inspected 83 site plans or subdivisions/condominiums.
- Performed herbicide applications on nine drainage systems totaling almost 29 miles.
- Secured financing for 18 maintenance or petitioned projects totaling \$783,750.
- Processed 724 drain orders totaling \$2,604,955.
- Received one township resolution to allow us to exceed the statutory spending limit for maintenance.

In 2018 there were four different pieces of legislation (House Bills 6374-6377) that made changes to the Drain Code. These changes became effective on March 28, 2019. The most significant of these changes in my mind is that the Drain Commissioner now determines necessity for public health for purposes of at-large assessments and makes these decisions within 10 days after a finding of necessity by a Board of Determination (BoD). Previously the BoD made this determination at a public hearing, often without having much understanding of the public health benefits of a drain project. Many of the other changes involve procedures relating to intercounty drains.

After my 13th year as Drain Commissioner and my 33rd year working in the Drain Office, it seems like we face ever-increasing challenges to maintain the drainage that residents expect. I'm thankful for my dedicated and caring staff that continually provides outstanding service to county residents and others. I sincerely appreciate Jon Morrison, my Deputy and staff Engineer; Lynn Cech, Drain Assessing Specialist; Cheri Theis, Drain Accounting Specialist; David Seeger, Drain Maintenance Worker; and Dean Morton, Engineering Technician. As always, we strive to make dealing with the Drain Office a positive experience. I also thank the Board of Commissioners, the Road Commission staff, local units of government, and the county residents for their continued support.

PETITIONS

A summary of active drain petitions

New Petitions Filed in 2018

There were no new drain petitions filed in 2018. Two were provided to landowners for signatures but were not returned prior to the end of 2018.

Ongoing From Prior Years

#720 Peck Drain – Located in Sections 4, 5, 8, & 9 in Essex Township and Village of Maple Rapids

The drain was petitioned by landowners in June of 2012 and was determined necessary at an August 10, 2012 Board of Determination meeting. Plans are complete, and the project is expected to be bid and constructed in 2019.

#897 Waltz and Sturgis Drain – Located in Sections 1, 11, 12, and 14 of Dallas Township and Village of Fowler

Petitioned in April of 2014 by the Village of Fowler and determined necessary at Board of Determination meeting in July of 2014. Spicer Group was the engineer and also assisted with a FEMA Hazard Mitigation Grant application. The project was bid out in October of 2017 after receiving Notice of Award of the grant. T.H. Miller Excavating and Pung Excavating were awarded the construction contracts. Construction began in January of 2018 and was completed in May of 2018. We are still awaiting final FEMA reimbursement of eligible expenses.

#950 Carter-Burke Drain – Located in Sections 13 and 24 of Watertown Township.

Petitioned by landowners in July of 2015 and Order of Necessity signed at a September 2015 Board of Determination meeting. Eng. Engineering & Surveying was selected as the project engineer. The project was bid out in June of 2018 with TL Contracting being awarded the contract. Construction was completed in November, and final restoration of the project area will take place in the Spring of 2019.

#477 Faiver Drain – Located in Section 7 of DeWitt Township and Sections 1 & 12 of Watertown Township

Drain improvements and new branches were petitioned by landowners in July of 2015, and the Board of Determination signed Order of Necessity in October of 2015. Spicer Group serves as the project engineer. Construction plans are complete and the project is ready to bid as soon as the one remaining easement is secured. Bidding is expected in spring 2019 with construction taking place later in the year to be completed by mid-October.

#956 Timber Ridge Drain – Located in Sections 28 and 33 of Bath Township

Petitioned by landowners in December of 2015. The Board of Determination issued its Order of Necessity in June of 2016. LSG Engineers & Surveyors has completed the project design. Easement acquisition is in progress and has been progressing slowly but bidding is expected in summer or fall of 2019 with construction taking place later in 2019. Construction should be complete in 2019, however final restoration may not be until spring of 2020.

#087 Riverside Drain – A proposed drain in Section 18 of Watertown Township

A landowner petition was received in August of 2016 and an Order of Necessity signed at a November 2016 Board of Determination Meeting. DC Engineering was selected as the project engineer. Construction plans are complete and ready for bidding, however easement acquisition on this project has been slow and has been met with significant resistance from landowners. If easement acquisition is successful, then the project should be able to move forward quickly. Hopefully this project can be bid out during summer of 2019 with construction taking place later in 2019.

#089 Looking Glass Brook Drain – A proposed drain in Section 18 of Watertown Township

A petition from landowners was received in February of 2017, and an Order of Necessity was signed at a July 2017 Board of Determination Meeting. Conceptual designs have been prepared by the project engineer, DC Engineering. This project has stalled a bit but is still expected to move forward. We are hopeful that easement acquisition can take place in 2019 with bidding and construction likely in 2020.

#627 Loesch Drain – Located in Section 13 of Watertown Township and Sections 18 and 19 of DeWitt Township.

The Clinton County Road Commission petitioned for improvements in May of 2017, and a Board of Determination issued an Order of Necessity in August of 2017. Construction plans and bidding documents were finalized by C2AE in the spring of 2019, and the project was bid in March of 2019. Construction is expected to begin in June of 2019 after financing is secured. Construction will be completed by fall, and the \$250,000 project will be assessed over three years.

#913 Westphalia and Riley Drain – Located in Sections 24 & 25 of Westphalia Township and Sections 30, 31, & 32 of Riley Township.

A petition from landowners was received in June of 2017 and Order of Necessity signed at an August, 2017 Board of Determination meeting. DC Engineering was hired to develop construction plans and bidding documents. The project is ready to bid out. Easements have been sent to landowners for signatures, and as soon as all have been secured, we will move quickly to bidding. Construction is expected in the summer or fall of 2019.

Applications to Lay Out and Establish A Drainage District

#090 Herbison & Wright Drain – A proposed drain in Section 11 and 14 of Eagle Township

Application to Lay Out and Designate a Drainage District received from landowners in April of 2016. DC Engineering has performed survey work to determine a drainage district boundary and estimated costs for improvements. The Order for Laying Out and Designating a Drainage District was signed in March of 2018. In June of 2018 the petition was sent to a property owner for signatures but has not been returned as yet.

#091 Summer Lane Drain – A proposed drain in Section 16 and 17 of Watertown Township

An Application to Lay Out and Designate a Drainage District was received from landowners in October of 2018. It is expected that the Order for Laying Out and Designating a Drainage District will be signed soon. A petition will then be drafted and provided for circulation. Assuming the petition is returned, the project is expected to be relatively minor and involve repair or replacement of an existing private drain tile servicing a portion of the Summer Lane subdivision.

Petitions Prepared for Circulation in 2018 but Not Filed

#090 Herbison & Wright Drain – A proposed drain in Section 11 and 14 of Eagle Township

See above. This is expected to be turned in for processing in 2019 but has not yet been received.

#840 Steel & Wallbridge Drain – Located in Sections 16, 21, 22, & 28 of Bingham Township and City of St. Johns

Petition paperwork was provided to concerned landowners in October of 2018. The petition was returned in January of 2019, and the signatures were validated. A Board of Determination meeting will be scheduled in the spring.
