

RESOLUTION 2001-7

ORDER AND DETERMINATION BY THE CLINTON COUNTY BOARD OF COMMISSIONERS TO ANNEX CERTAIN LANDS TO THE VILLAGE OF FOWLER, MICHIGAN

WHEREAS, the Village Council of the Village of Fowler, has by resolution, determined to petition the Board of Commissioners of Clinton County to annex certain lands as herein described and also described in said petition and resolution, to the Village of Fowler, and

WHEREAS, such petition and resolution gives as the reason for said proposed annexation that it is necessary to promote the business economy and development of the Village of Fowler, and

WHEREAS, such resolution as presented was duly signed by the President and Clerk of the Village of Fowler, and

WHEREAS, notice of the hearing to be held by the Clinton County Board of Commissioners on the question of proposed annexation was published or posted, as required by statute, as appears by the affidavit of Rhonda S. Feldpausch, Village Clerk, in the files of this matter, and

WHEREAS, such notice also contained a description of the premises to be be annexed, and

WHEREAS, all persons interested have been given an opportunity to be heard at a public meeting of the Clinton County Board of Commissioners, and

WHEREAS, all proceedings pursuant to Section 6, Chapter 14, of Act 3 of the Public Acts of 1895 of the State of Michigan, (MCL 74.6; MSA 5.1470), have been complied with,

NOW THEREFORE, It is hereby ordered and determined that the following described lands in the Township of Dallas, Clinton County, Michigan:

The West 18.5 acres of the part of the East 1/2 of the East 1/2 of the Southwest 1/4 of Section 11, T7N, R4W, Dallas Township, Clinton County, Michigan, lying North of the Central Michigan Railway. **ALSO** the west 1/2 of the East 1/2 of the Southwest 1/4 of Section 11, **excepting** the right of way of the Central Michigan Railway and also **excepting** 24 rods in the width off the west side of the parcel. (All of parcel number 040-011-300-010-00)

ALSO all of the right of way of the Central Michigan Railway between the North-South 1/4 line of Section 11, T7N, R4W, Dallas Township, Clinton County, Michigan and west line of the East 1/2 of the Southwest 1/4 of said Section 11, Except the West 24 rods thereof:
(Part of Parcel Number 040-011-500-001-00)

be and the same are hereby annexed to the Village of Fowler, Clinton County, Michigan and said lands shall be considered hereafter to be included within the corporate limits of said Village.

IT IS FURTHER ORDERED that a copy of this Order and Determination to annex territory to the Village of Fowler, Michigan, shall be entered on the records of the Clinton County Board of Commissioners and that a certified copy of this Order and Determination shall be transmitted by the Clerk of the Clinton County Board of Commissioners to the Clerk of the Village of Fowler, and to the Secretary of State, State of Michigan and that this Order and Determination shall be prima facie evidence of such a change of boundaries of the Village of Fowler and of the regularity of such proceedings.
