

## RESOLUTION 2001-13

### ORDER AND DETERMINATION BY THE CLINTON COUNTY BOARD OF COMMISSIONERS TO ANNEX CERTAIN LANDS TO THE VILLAGE OF FOWLER, MICHIGAN

**WHEREAS**, the Village Council of the Village of Fowler, has by resolution, determined to petition the Board of Commissioners of Clinton County to annex certain lands as herein described and also described in said petition and resolution, to the Village of Fowler, and

**WHEREAS**, such petition and resolution gives as the reason for said proposed annexation that it is necessary to promote residential, commercial, industrial and economic development of the Village of Fowler, and

**WHEREAS**, such resolution as presented was duly signed by the President and Clerk of the Village of Fowler, and

**WHEREAS**, notice of the hearing to be held by the Clinton County Board of Commissioners on the question of proposed annexation was published or posted, as required by statute, as appears by the affidavit, in the files of this matter, and

**WHEREAS**, such notice also contained a description of the premises to be annexed, and

**WHEREAS**, all persons interested have been given an opportunity to be heard at a public meeting of the Clinton County Board of Commissioners, and

**WHEREAS**, all proceedings pursuant to Section 6, Chapter 14, of Act 3 of the Public Acts of 1895 of the State of Michigan, (MCL 74.6; MSA 5.1470), have been complied with,

**NOW THEREFORE**, It is hereby ordered and determined that the following described lands in the Township of Dallas, Clinton County, Michigan:

All that part of the East ½ of the East ½ of the Southwest ¼ of Section 11, T7N, R4W, Dallas Township, Clinton County, Michigan, lying South of the Central Michigan Railway right of way. Said parcel being more particularly described as: beginning at the South ¼ corner of said Section 11; thence S89° 53'16"W 662.95 feet along the South line of said section; thence N00°02'43"W 354.11 feet along the West line of the East ½ of the East ½ of the Southwest ¼ of said section to the South line of the railroad right of way; thence N89°18'24"E 663.04 feet along said South right of way line to the North-South ¼ line of said section; thence S00°02'14"E 360.83 feet along said North-South ¼ line to the point of beginning. Containing 5.44 acres (Parcel Numbers 040-011-300-020-00 and 040-011-300-025-00)

be and the same are hereby annexed to the Village of Fowler, Clinton County, Michigan and said lands shall be considered hereafter to be included within the corporate limits of said Village.

**IT IS FURTHER ORDERED** that a copy of this Order and Determination to annex territory to the Village of Fowler, Michigan, shall be entered on the records of the Clinton County Board of Commissioners and that a certified copy of this Order and Determination shall be transmitted by the Clerk of the Clinton County Board of Commissioners to the Clerk of the Village of Fowler, and to the Secretary of State, State of Michigan and that this Order and Determination shall be prima facie evidence of such a change of boundaries of the Village of Fowler and of the regularity of such proceedings.
